BEING A BY-LAW TO AMEND BY-LAW 3475/56/97, AS AMENDED, BEING A BY-LAW ESTABLISHING PARKING LOTS IN THE CITY OF PORT COLBORNE AND FOR REGULATING, SUPERVISING & GOVERNING THE PARKING OF VEHICLES THEREIN & THEREON & TO PROHIBIT THE PARKING OR LEAVING OF MOTOR VEHICLES, PRIVATE PROPERTY OWNED OR OCCUPIED BY THE CORPORATION OF THE CITY OF PORT COLBORNE OR ANY LOCAL BOARD THEREOF

  - "Special Permit" means a parking permit issued by the Corporation of the City of Port Colborne to allow permit parking in lots as set out in Schedule "A" of this bylaw.
- 4. That Section 4.3 Permit Parking, to Bylaw 3475/56/97, as amended, be further amended by adding thereto the following:

Insert "or special permit"

"A daily (or special permit) must be clearly displayed in the front windshield of the vehicle. A seasonal permit must be clearly displayed on the tongue of the boat trailer".
